

House Rules (HO) of Camping PINK Event GmbH and Camping PINK Mayer-Baumessner

Status May 2023

§ 1. Everyone who enters the Camping PINK area respects the rules of this House Rules (HO) and unreservedly acknowledges the provisions of these rules. Any violation of the following policies may result in denial of access to the camping area or expulsion from the site or closure of the site.

§ 2. Access to the campground is available during major events on Wednesday from 12:00 pm to 11:00 pm., between Thursday and Friday from 7:00 am to 11:00 pm, and on Saturday from 7:00 am to 6:00 pm. After that the campsite will be closed. Reserved/paid bookings lose their validity from Saturday, 18:00 pm. **Access to the campsite outside the mentioned check-in times is not possible without exception.** However, we offer you the possibility to park directly at our check-in on a small green area until you can enter the campsite. The campsite closes on Monday after the event weekend at 10:00 am at the latest. The area must be vacated by then.

§ 3. At check-in you will receive the accreditations (one wristband per person and one sticker per vehicle) for access to the campsite. These must be immediately attached to the wrist or windshield to gain access. The binding house rules and terms and conditions have already been sent to you at the time of booking. Furthermore, these are signposted in the check-in and are thus accepted for bookings on site.

§ 4. Make sure that you always have a valid ID (ID card, passport or driver's license) with you.

§ 5. You must follow the instructions of the security and organizational staff.

§ 6. For safety reasons, after the first access to the camping area, no further leaving of the camping area with vehicles is allowed during the contract period.

§ 7. It is not allowed to surround the own pitch with ditches, fences and other barriers.

§ 8. Pets are allowed only at Camping PINK am Birkmoarhof, Camping PINK Mayer-Baumessner and on the additional area PINK Light, pets are not allowed at Camping PINK Premium. Dogs are not allowed to run around freely (leash and muzzle compulsory). The pet owner is responsible for any incidents that may occur.

§ 9. To make your stay as pleasant as possible, we have set up information points. There you can ask questions, make requests, suggestions and complaints. We will process these promptly within the scope of our possibilities and look for solutions together with you.

§ 10. Persons under the age of 18 are prohibited from consuming alcohol on the premises. Persons who are obviously under heavy influence of alcohol and/or drugs and want to enter the camping area can be turned away. The respective valid youth law applies. Persons who are or have been demonstrably under the above-mentioned influences have no claim to reimbursement of admission tickets, travel expenses and/or other costs.

§ 11. Bringing food and drinks into the camping area is allowed. Please note that these are not packaged in glass, as the use of glass is not permitted anywhere on the campground. Also, it is not

allowed to bring large amounts of alcohol and food. These may be inspected by Camping PINK staff and their consumption on the premises may be prohibited. It is also not allowed to bring external guests on the site.

§ 12. Wearing club clothing or clothing that indicates affiliation with a particular political or social/ideological movement may be refused. Clothing with the branding of a Formula 1 or MotoGP team is allowed.

§ 13. Drugs, weapons, drones, laser pens, fireworks, smoke powder, smoke bombs, gas and oil lamps, dry ice, large gas bottles (>11kg), candles and torches, and dangerous objects in general are not allowed. Throwing objects of any kind, or spilling liquids of any kind, especially if this is done in the direction of other people, is prohibited.

§ 14. Socially acceptable behavior is required on the campsite. Threats, use of force, discriminatory language and/or gestures, sexual harassment and any other anti-social behavior will not be tolerated. Such an infraction may result in a warning and subsequent ejection from the premises. Any damages are to be reimbursed by the offending party. In addition, the operator reserves the right to take legal action (e.g. action for disturbance of possession, report to authorities or court, etc.).

§ 15. It is prohibited to climb, clamber or step over structures and facilities intended for general use, in particular fences, chairs, benches, tables, fencing, barriers, lighting systems, trees, stages, poles of all kinds, decorations or the like. Likewise, these may not be labeled, painted or pasted.

§ 16. The parking of bicycles, electric scooters, Segways or similar vehicles or the attachment of these to structures, fences, barriers, etc. represents a safety risk and is prohibited. In case of violation, these can be removed at the expense of the causer.

§ 17. The setting up of tents, folding trailers, caravans, motor homes, cars, etc. and the parking of objects on the site is at your own risk. There will be no custody by the lessor.

§ 18. The distribution of advertising material, leaflets, flyers and/or the trade of goods or the sale/brokerage of tickets is prohibited in the camping area without the written permission of the organizer.

§ 19. You may be denied entry to the venue for security reasons (e.g. inappropriate clothing or behavior, heavy alcohol consumption, etc.) or you may be expelled from the venue for these reasons. The use of surveillance cameras is subject to data protection.

§ 20. Any person entering the campsite and the event site agrees that sound and image recordings may be made of him/her free of charge, which may be used free of charge by means of direct or time-shifted video display, direct or time-shifted transmission or other transmission or recording, photographs or other present and/or future media technologies/promotional purposes. The organizer reserves the right to monitor the entire event area or parts thereof by a video system and. Without accreditation, guests are not allowed to use professional camera equipment on the premises itself.

§ 21. Smoking is not permitted in the lodging and sanitary rooms, nor in the designated non-smoking areas.

§ 22. It is forbidden to defecate outside the sanitary facilities.

§ 23. Waste must be deposited in the plastic bags provided upon arrival, properly sealed and separated by type of waste, at the waste collection point in the designated areas. Cigarettes must be disposed of in the containers provided. At departure, the campsite and the accommodation must be left free of waste and swept clean. In case of non-compliance, the costs incurred may be charged.

§ 24. Your pitch booking at Camping PINK am Birkmoarhof, Camping PINK Mayer-Baumessner and Camping PINK Premium includes 1 electricity connection. Electricity boxes are regularly distributed on the site and are at your disposal.

Please note that only 1 Schuko socket 230 V (CEE 7/3), but no heavy current with 400 V) is available for you at the camping site. If further sockets are used, they will be disconnected from the mains!

Remember to bring your own Euro plug with power cord and/or cable drum of min. 25 m. 50 m cable length may be required to the nearest power distributor. Please note that the electricity networks for any kind of heating/cooking (electric heaters, cooking/grilling) are not designed for the operation of air conditioners or high power consumers. We reserve the right to prohibit or restrict the use of such electrical loads for safety reasons. If poor or defective consumers are used, such as old refrigerators, damaged cable drums, etc., the power connection will be blocked and permanently disconnected for safety reasons. Any damage incurred must be compensated by the tenant.

Attention: It is not allowed to operate generators brought by yourself.

§ 25. No electricity is provided at the PINK Light additional area. Furthermore, only portable toilets are available here. You can use the sanitary facilities, as well as washing up facilities for dishes free of charge in the camping area of Camping PINK am Birkmoarhof (approx. 800 m away), which is within walking distance.

§ 26. There is no direct water and waste water connection at the pitch. Fresh water connections are available centrally in the area of the sanitary facilities and sporadically in separate water containers on the camping meadows. There will be signs indicating if drinking water is available. Only water containers are available on the additional area PINK Light.

§ 27. Barbecue is allowed only in suitable containers on the campsite (wood, barbecue coal, gas). Lighting a campfire is prohibited.

Open fire and the use of alcohol or gasoline heaters are not allowed. Gas appliances must be equipped and maintained according to the standards. If a cooking tent is set up, an approved fire extinguisher must be available.

§ 28. All accidents or damages have to be reported immediately to the organizer - even if the visitor is obliged to repair them himself. Any costs incurred will be invoiced.

§ 29. For emergencies and as a service there is a 24-hour telephone hotline, which can be reached on site during the event.

In case of danger (fire, accidents, etc.) the security staff, the organizer and/or the blue-light organizations (fire department 122, police 133, ambulance 144) must be informed. Their instructions must be followed. Please also pay attention to announcements made by the public address system or megaphones.

§ 30. All entrances and exits as well as emergency, escape and rescue routes must be kept clear.

§ 31. It is expressly pointed out that in the event of a storm, all participants must take suitable protective measures on their own responsibility. In particular, standing under trees or in the immediate vicinity of technical structures may pose a risk and must therefore be avoided.

§ 32. For entering the event location (Gastronomy/Party zones), it is necessary to carry an admission ticket and/or accreditation. The accreditation must be presented upon entry and within the event premises upon request of the organizer, the steward service or the police. Upon request, proof of identity shall be provided by means of an official document.

§ 33. The assigned steward service is authorized to check persons, also by using technical aids, to determine whether they pose a security risk due to alcohol or drug consumption or because they are carrying weapons or weapon-like or dangerous or flammable objects. With the consent of the person being searched, the steward service is authorized to search items of clothing and containers being carried, in particular for prohibited items as defined in Section 36, not only upon entry but also during the stay at the event site (catering/party zones). The prohibited items listed may be taken away. These measures may also be carried out by the police in case of suspicion of a criminal act or at their request.

§ 34. The security personnel or the organizer are entitled to deny access to the venue to persons who may pose a security risk (e.g. due to excessive consumption of alcohol or the carrying of prohibited or dangerous objects). The same applies to persons who refuse a search of their clothing, bags or containers or a possible ID check. In individual cases, the security service or the organizer is entitled to carry out such checks even on persons participating in the event who are already in the venue.

§ 35. The following items may not be brought into the event location (Gastronomy/Party zones).

In case of doubt, the classification of items as prohibited or permitted within the meaning of these house rules is the responsibility of the security staff or the organizer.

- Weapons of any kind and objects that can be used as weapons or projectiles (slingshots, knives, etc.)
- Objects made of glass (e.g. glass bottles, glass containers, etc.), objects made of fragile or splintering material (e.g. jugs, etc.)
- Pyrotechnic objects of any kind, flammable liquids, gas spray cans, corrosive or easily combustible substances

- Containers with substances that can endanger health
- Drugs and other intoxicants
- dry ice
- High-visibility vests / signal vests (worn by visitors)
- laser pointers
- Drones and other flying objects (e.g. sky lanterns)
- Powder or coarse-grained materials
- Objects with discriminatory or provocative text or images
- Professional photographic and video equipment
- Noisy instruments (e.g. air horns, gas horns, megaphones)
- Animals of any kind (except guide dogs and partner dogs with muzzle on leash)
- Bulky objects (e.g. bicycles, folding chairs, etc.)
- Play and sports equipment (e.g. electric cars, scooters, skateboards, etc.)
- Alcoholic beverages
- Umbrellas
- Flagpoles
- Selfie stick
- Suitcases (backpacks, as well as gym bags made of fabric smaller than a DIN A3 sheet with the dimensions 42 cm X 29.7 X 21 cm (H/W/D) are allowed)

§ 36. After the end of the event, all visitors must leave the event premises (Gastronomy/Party zones).

§ 37. The collection of objects, which are given out against a deposit, by persons, who have not given the deposit, is prohibited and leads otherwise to an exclusion from the event without return of the deposit.

§ 38. In case of repeated non-observance of our house rules despite warning, the access to the camping area as well as to the event location (gastronomy/party zones) will be irrevocably denied for time or permanently (house ban). Visitors and persons who have been denied access in this manner cannot - for whatever reason - demand reimbursement of camping fees, admission tickets or travel expenses.

§ 39. The night rest is valid from 02:00 to 07:00 o'clock. Then the volume of the loudspeakers and music systems must be selected so that residents and other campers are not disturbed. The time restriction may vary by the campsite operator and/or due to official requirements. The use of radios, etc. is permitted provided that it does not cause a disturbance to other guests. The use of large and professional sound equipment is not allowed.
